**Entry Information Requirement:** Due to the short time period for entering this show, this show will ONLY be accepting online entries on Equestrian Entries at <a href="www.equestrianentries.com">www.equestrianentries.com</a></a> **No mailed entries or entries by fax or email will be accepted for this show.** 

Competitors are responsible to include a copy of all up to date USDF and USEF memberships for horse, owner, rider, trainer, and coach listed on entry form or pay non-member fees. Freestyle classes must include a copy of a qualifying test with entry.

**Freestyles:** Show management requests that all freestyle riders must check in with the announcer at the show with their music. Show management requests that the music be provided on your cell phone with a head phone jack AUX adapter dongle for your phone.

**Times for this show:** Because this is a one-ring show, we will take the first 65 rides for each show day. Qualifying classes will be judged by different judges or panel each day to assist with riders being able to obtain their qualifying scores. Management reserves the right to close entries BEFORE the closing date if the ring limit has been met for the day. Riders wishing to enter once the ring limit has been met will be placed on a waiting list and taken in the order in which the entries were received.

**USEF Equine Vaccination Rule & Health Requirements for entry to show grounds in 2021:** All horses entering the showgrounds of a USEF licensed competition MUST be accompanied by documentation showing vaccinations for Equine Influenza Virus and Equine Herpes Virus (Rhinopneumonitis) within 6 months of the show dates and must have a current negative EIA/Coggins test (within 12 months of the show dates). **This is mandatory for every horse entry. See USEF rule GR845.** Also, a health certificate (30-day) is needed on all out of state horses.

**Reminder:** This is two shows, you must submit two entry forms (one for each show) if entering both shows.

# **USEF SAFE SPORT TRAINING REQUIREMENT**

Starting January 1, 2019, if you are a USEF Competing Member 18 years of age or older you are required to complete the core Safe Sport Training within 30 days of activating your membership.

If you do not complete the training, you are ineligible to participate in all USEF activities including competitions.

**COVID-19:** This show will be implementing the necessary requirements at this show to keep competitors and staff as safe as possible due to the COVID-19 virus. This may include, but not be limited to, requirement to wear a mask, social distancing, minimal contact between staff and competitors, and limited or spaced stabling. Competitors will be updated through group correspondence as to the safety protocols with which this horse show will operate with, as this is a dynamic situation that changes differently within each state.

#### **Entry and Stabling Fees:**

Office fee per entry: \$40 per horse/rider combination per entry per show

**Late fee per entry:** \$50 for entries received after the closing date of June 28, 2021

**Post entries at show:** Will be taken as scheduling permits, class fee plus \$10 **Rider/Horse change:** \$25 for either rider or horse change after entry submitted

**Non-Compete horse:** \$75 per day or \$150 for the 3 day-weekend for non-competing horses on grounds.

Must fill out entry form for bridle number and pay stabling and office fees.

Stabling/Tack stalls: Weekend stabling for entire weekend, Thursday noon/12 PM through Sunday 7 PM

\$185 for stabling in the Main barn, north & south aisle (10 x 12 permanent stalls with doors). \$175 for California (CA) barn (permanent barn with roof, no sides) or Kentucky (KY) barn (permanent barn with roof and sides). Both barns are 12 x 12 temporary stalls with doors.

Daily stabling: \$100/24-hour period (Thurs PM - Fri PM or Fri PM – Sat PM or Sat PM - Sun PM).

Daily stabling available only in California or Kentucky barns.

**Early arrival fee:** \$35/stall for horses that need to come on Wednesday

**Jump-out fee:** \$75/day grounds fee

**Bedding:** \$10 per bag of shavings can be pre-ordered on entry or on grounds in show office.

**Check-in times for show:** Stabling will be available at noon on Thursday, July 8.

(Early arrivals must contact management before show and pay early arrival fee.)

Rings will be available for schooling after 3 PM on Thursday, July 8. Show office will be open for competitors after 2 PM on Thursday, July 8.

**Trailer parking:** For weekend trailer parking, after unloading, please park on hill off of Homestead Trail.

**Directions:** I-394/ Hwy 12 to County Road 6 North. Turn left onto CR 201/Homestead Trail. Alpine Farms, 2182 Homestead Trail, Long Lake. MN 55356 will be on the right.

**Entry Cancellation/Refunds:** Cancellations must be received in writing, either by mail or e-mail, prior to or on the closing date, will be refunded minus the office fee. **No Refunds for any reason, including an Act of God, after the closing date or throughout the competition.** 

**No Shows:** All "No Shows" that have not contacted the show office prior to their first ride will be considered a scratch for the rest of the show and time slots may be filled. Exhibitors enter with this understanding and agreement.

**Great American/USDF Qualifying Classes:** Indicate that the class is to count for qualifying by placing a **Q** after the class number. Qualifying will not require a separate ride. An additional \$15 USDF Qualifying fee over the class fee will be charged. A \* indicates a Great American/USDF 2021 qualifying class on the class list.

**Opportunity Classes:** Opportunity classes are intended for entry level riders. Horses and riders entered only in "Opportunity" classes are exempt from USEF and USDF membership requirements, and do not have to pay non-member (show pass) or HID fees. Federation and drug fees do not apply. Horses entered only in these classes are still subject to and must comply with the Drugs and Medication rules and are subject to drug testing. Riders and/or horses entered in "Opportunity" classes may not cross enter into other recognized classes at the show. See USEF rule GR821.

**Confirmations/Times:** Unofficial times will be available on <a href="www.foxvillage.com">www.foxvillage.com</a> at least 48 hours prior to the start of the show. Emails must be clearly printed on the entry form to receive entry confirmations. It is the responsibility of the rider to inform management of any time conflicts as soon as possible after receiving the schedule. An official schedule will be posted in the show office by noon prior to the start of the competition.

**Arenas:** Classes will be held in one outdoor large  $20m \times 60m$  show rings with All Weather Premium footing. Adjacent outdoor warm-up arena with optional  $20m \times 60m$  indoor ring. Separate lunging area available throughout the show.

**Awards:** Ribbons to sixth place in all classes except qualifying classes. Divisions may be split if there are more than 10 entrants in a class. Trophies may be awarded in classes of 3 or more. Champion and Reserve Champion ribbon and trophy awarded for the highest percentage at each level and division JR-YR, AA, Open. Champion and Reserve ribbons awarded at the end of each weekend. Divisions may be run concurrently as one class. When no designation is made, riders will automatically be entered as open. Riders can only enter one division per class.

**Stabling and Tack:** All stabling is limited and will be accommodated on a first come, first serve basis. Horses not required to have a stall, but non-stabled horses must pay the jump-out fee. Bedding will be available for sale on the show grounds. Stabling requests for the specific barns will be honored when possible. The north aisle of the Main barn is available, which has direct access to the indoor warm up arena and a dedicated wash stall. The California barn has a roof and no sides; the Kentucky barn has a roof and sides. Horses are required to be bathed in the wash rack available in their specific stabling area. Group stabling will be placed in the area where the majority of the group has requested stalls. All horses in the group stabling will be required to pay the rate of the stall regardless of what was requested on the entry unless permission is given to split groups.

**Other:** Food concessions will **NOT** be available on the show grounds during normal show hours due to COVID-19 precautions. Alternate food options will be posted at the show. Competitors are strongly encouraged to bring their own food, drinks, and snacks from home to aid in the social distancing. All dogs must be leashed and attached to a person or immovable object.

Golf Cars/Mopeds/Etc: Minors who do not have a valid driver's license which allows them to operate a motorized vehicle in the state in which they reside will not be permitted to operate a motorized vehicle of any kind, including, but not limited to, golf carts, motorcycles, scooters, or farm utility vehicles, on the competition grounds of licensed competitions. Minors who have a valid temporary license may operate the above described motorized vehicles as long as they are accompanied by an adult with a valid driver's license. The parent/legal guardian or individual who signs the entry blank as a parent or guardian of a minor operating a motorized vehicle in violation of this rule are solely responsible for any damages, claims, losses or actions resulting from that operation. Violations of this rule will be cause for penalties against those responsible for the child committing the offense. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule.

The unsafe use of personal electronic transport devices, as determined by the competition officials and management in their sole discretion, that do not require a driver's license to operate, including but not limited to segways, hover boards, and single wheeled scooters is prohibited on competition grounds. Operating such devices in areas where people gather may be deemed "unsafe use" if there is a risk of harm to others. If the operator of the device is a minor, the parent/legal guardian or individual who signs the entry blank as a parent or guardian of a minor operating the device in violation of this rule is accountable and may be subject to penalties. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule.

Weather/Acts of God/Accidents or Emergency Policy: Management reserves the right to cancel any classes due to hazardous weather, Acts of God, Accidents, or Emergencies. Every effort will be made to reschedule with priority given to any qualifying classes being offered. No refunds for cancellations due to hazardous weather, Acts of God, Accidents, or Emergencies.

### Regional Adult Amateur Equitation Program

The USDF Regional Adult Amateur Equitation Program recognizes adult amateurs competing in equitation and promotes correct seat, position, and use of the aids in dressage. An Adult Amateur Equitation Regional Final class presented by Big Dee's Tack and Vet Supply will be held in conjunction with each of the nine USDF Regional Dressage Championship competitions, providing adult amateurs with additional opportunity for recognition. Ribbons awarded through 8th Place and gift certificates awarded to top three riders.

Adult amateurs wishing to qualify to compete in an Adult Amateur Equitation Regional Final may do so by meeting the following requirements.

#### Qualifying Requirements

To be eligible for the USDF Adult Amateur Equitation Regional Final class, rider must have

- Earned a score of 70% or higher in any dressage seat equitation class (except walk/trot) at a USEF-licensed/USDF-recognized Dressage competition within the qualifying period of the applicable regional championship.
- b) Qualified to compete in any regional dressage championship class (excluding freestyles).

#### Membership Requirements

- Rider must have a USDF Participating Membership at the time the qualifying score is earned, and at the time of the Regional Final class.
- Rider must be an adult amateur, in accordance with GR1306 of the USEF rules, and be designated with USEF as an adult
  amateur when the score is earned, and at the time of the Regional Final class.
- Owner must have a USDF Participating or Business Membership when the qualifying score is earned, and at the time of the Regional Final class.
- Horse must have a USDF Lifetime Horse Registration when the qualifying score is earned, and at the time of the Regional Final class.

#### **General Regulations, Policies and Entry Specifications**

# EVERY CLASS OFFERED HEREIN WHICH IS COVERED BY THE RULES AND SPECIFICATIONS OF THE CURRENT FEDERATION RULE BOOK WILL BE CONDUCTED AND JUDGED IN ACCORDANCE THEREWITH.

US EQUESTRIAN FEDERATION rules are in force from the moment show management allows access to the showgrounds. This includes conduct, correct saddlery and equipment, and attire.

Liability: Horses by their inherent nature present a risk. This show, the management, the USEF Licensee, and the facility will not be responsible for any loss or damage or injury to horses exhibited, or for any article of any kind or nature that may be lost or destroyed, or in any way injured. Each exhibitor will be responsible for any injury that may be occasioned to any person, whomsoever, by any horse owned or exhibited by said exhibitor and shall indemnify the show, the management, the show committee and volunteers, the USEF Licensee, the USEF and USDF, or any member thereof, against all claims and demands, of any nature or kind, that may grow out of any injury occasioned by any horses owned or exhibited by them, or arise from the negligence of the person in charge of any such horse. All horses exhibited in this show participate entirely at the owner's risk. Neither the Organizing Committee, show volunteers and staff, the facility or its owners, USEF or USDF or their members will be responsible for any damage, injury, or loss to persons, horses, or property of exhibitors or spectators. All owners and competitors are personally responsible for damages to third parties caused by themselves, their employees, their agents or their horses. They are therefore strongly advised to take out third-party insurance providing full coverage for participation in equestrian events at home and abroad, and to keep the policy up to date

Additionally, Alpine Farms, and their officials, sponsors and employees will not be responsible for any accident or loss which may occur to any exhibitor, spectators, guest, rider, groom, attendant or other employee, animal or equipment at any of the competition.

#### **USEF Membership Statement (GR901.9)**

Life, senior active and junior active members shall be eligible to participate in all classes at Regular Competitions, Eventing Competitions at the Modified Level or above and Combined Driving Competitions at the Advanced Level, Dressage, Reining and Vaulting Competitions and Endurance Rides. A nonmember may participate as a handler, rider, driver, owner, lessee, agent, coach or trainer at Regular Competitions, Eventing Competitions, Dressage Competitions, Reining Competitions and Combined Driving Competitions upon payment of a \$45 Show Pass fee. Participants in the following classes are exempted from the Requirements of this rule: 1) leadline; 2) exhibitions; 3) games and races; 4) classes for 4-H members; 5) walk trot (exception: Friesian performance FR222) and academy classes (academy classes are classes limited to horses used regularly in a lesson program); 6) USDF introductory level tests, pas de deux and quadrille classes; 7) NRHA Endorsed Reining Competitions. 8) Opportunity classes, 9) citizens of other nations who have proof, in English, of current membership in good standing of their own National Federation, 10) USEA beginner novice division; and 11) assistant handlers in Dressage Sport Horse Breeding classes.

Exhibitors should exercise extreme caution before medicating their horses and should be aware of the US EQUESTRIAN FEDERATION rules governing drugs and medications. Any questions about the use of certain medications and regarding Rule IV should be directed to the USEF Federation Equine Drugs and Medications Program, 956 King Avenue, Columbus, Ohio 43212-2655. (800) 633-2472, (614) 299-7707, FAX (614) 299-7706.

**Warning:** Under the Equine Activity Liability Act, each participant who participates in an equine activity expressly assumes the risks of engaging in and legal responsibility for injury, loss, or damage to person or property resulting from the risk of equine activities.

A **trainer** is defined as any adult who has responsibility for the horse on the competition grounds and must sign the entry form.

**Bridle Numbers:** Bridle numbers must be worn at all times when a horse is being exercised or ridden.

**Musical Freestyles:** Music must be on good quality CD and must be presented to the announcer at least two hours before scheduled ride. The schedule for sound checks will be posted at the show.

**Protective Headgear Rule:** From the time horses are officially admitted to the competition grounds by competition management, anyone mounted on a horse at any time on the competition grounds including non-competing riders, riders on non-competing horses and those competing in all classes and tests must wear protective headgear as defined by this rule and otherwise in compliance with GR801. Any rider violating this rule at any time must be immediately prohibited from further riding until such headgear is properly in place. Protective headgear is defined a riding helmet which meets or exceeds ASTM (American Society for Testing and Materials)/SEI (Safety Equipment Institute) standards for equestrian use and carries the SEI tag. The harness must be secured and properly fitted.

Show Management reserves the right to vary or add officials and refuse any entry for a cause; to disqualify any exhibitor and/or his or her horse for cause; to cause an exhibitor to forfeit his or her ribbons and winnings for cause; to return any entry and/or stall fee before or during the show for cause; all without being liable for damage or compensation. Show management reserves the right to make any changes deemed necessary for the safe and efficient conduct of this competition.

**Important notice to all affected parties:** Third parties may come upon the property or enter the facilities where any herein described or listed event will occur; provided, that this is a license to enter the premises, for the purpose of observing or participating in the event, but not otherwise, and such license to any individual is subject to revocation by the owner, lessee or organizer, and entry for any purpose other than granted herein, shall be deemed criminal trespass and subject to appropriate legal proceedings.

**Attention Competitors:** Each competitor is responsible for supplying the show management with the correct and required association numbers of USDF and/or USEF for the horse, owner, rider, coaches, and trainer, before the day(s) of the competition. The scores of competitors who fail to supply correct numbers may not count towards national awards. All entries for Open Classes are taken on a first come, first served basis. Only one horse-rider combination per entry form.

**No Shows:** All "No Shows" that have not contacted the show office will be considered a scratch for the rest of the show and time slots may be filled. Exhibitors enter with this understanding and agreement.

**Sharps Disposal:** Competition management may fine any individuals including trainers, owners, exhibitors, or their agents up to \$100 for improper disposal of needles or other sharp disposable instruments. Containers are located at the end of each barn aisle and within center aisles when center aisles are present within the barns.

**Dogs:** Facility rules require that dogs must be on a leash (not to exceed 6 feet in length) or suitably restrained in a tack stall/cage etc. Loose animals/animals left in vehicles in distress, etc. can and will be removed from the grounds at the owner's expense.

Membership/Registration Requirements for GAIG/USDF Qualifying Classes: Riders must be current USDF Participating members & USEF members (Junior, Senior or Life) in good standing. Horses must be USDF Lifetime Registered and USEF Annual or Lifetime Recorded. Horses with only an HID are not eligible. Owners must be current USDF Participating or Business members & USEF members (Junior, Senior or Life) in good standing. For current Great American/USDF Championship requirements, go to www.usdf.org/competitions/competitionschampionships/regionals/index.asp.

**Show Schedule and Ride Time Conflicts:** It is the responsibility of the rider to inform the management of any time conflicts as soon as possible after receiving the schedule. Changes need to be requested in the show office by 3 PM the day prior.

#### FEDERATION ENTRY AGREEMENT

By entering a Federation-licensed Competition and signing this entry blank as the Owner, Lessee, Trainer, Manager, Agent, Coach, Driver, Rider, Handler, Vaulter or Longeur and on behalf of myself and my principals, representatives, employees and agents, I agree that I am subject to the Bylaws and Rules of The United States Equestrian Federation, Inc. (the "Federation") and the local rules of the competition. I agree to be bound by the Bylaws and Rules of the Federation and of the competition. I will accept as final the decision of the Hearing Committee on any question arising under the Rules, and agree to release and hold harmless the competition, the Federation, their officials, directors and employees for any action taken under the Rules. I also agree that as a condition of and in consideration of acceptance of entry, the Federation and/or the Competition may use or assign photographs, videos, audios, cable - casts, broadcasts, internet, film, new media or other likenesses of me and my horse taken during the course of the competition for the promotion, coverage or benefit of the competition, sport, or the Federation. Those likenesses shall not be used to advertise a product and they may not be used in such a way as to jeopardize amateur status. I hereby expressly and irrevocably waive and release any rights in connection with such use, including any claim to compensation, invasion of privacy, right of publicity, or to misappropriation. The construction and application of Federation rules are governed by the laws of the State of New York, and any action instituted against the Federation must be filed in New York State. See GR908.4.

**Safe Sport:** All USEF Life and Senior Active members, as well as participants who have regular contact with minor athletes, are required to comply with the U.S. Center for SafeSport training requirement to be eligible to participate in the competition. All participants must adhere to the U.S. Center for SafeSport Code, USEF Safe Sport Policy, and the Minor Athlete Abuse Prevention Policies. # 2021 Great American Insurance Group/USDF Regional Dressage Championships

A single Regional Dressage Championship program organized by the United States Dressage Federation (USDF), and recognized by the United States Equestrian Federation, Inc. (USEF), will be held in each of the nine USDF regions. In addition, Alaska and Hawaii may each hold state championships if an official request from a Group Member Organization (GMO) is received by April 1 of the prior year. The Regional Championship Program Rules can be found on the USDF website at <a href="https://www.usdf.org">www.usdf.org</a>. Please refer to the 2021 USDF Member Guide for the comprehensive list of rules and requirements for this program.

#### Membership/Registration Requirements for Qualifying and Championships

All memberships and registrations/recordings must be correct and current at the time qualifying scores are earned and at the time of the championships.

#### Rider:

- Must have a USDF Participating\* Membership (PM).
- Must have a USEF membership (Junior Active, Senior Active, or Life).

#### Horse:

- Must have a USDF Lifetime Horse Registration (LHR).
- Must have a USEF (Annual or Lifetime) Horse recording.
- USDF horse registration and USEF horse recording must be in the name(s) of the current owner(s) or lessee(s). A horse is not required to have breed registry papers.

#### Owner:

- Must have a USDF Participating or Business Membership and a USEF membership (Junior Active, Senior Active, Life, or Recorded Farm (with Active Farm Owner)). If the horse has more than one owner, at least one owner must have both active USEF membership and active USDF Participating or Business Membership and must be the owner of record with USEF and USDF. For a business or farm to be the valid owner under this requirement, it must be listed as an owner of the horse with both USEF and USDF.
- \* PMs are USDF members who join USDF directly. USDF Group Members (GM) are ineligible.

**Minimum Qualifying Scores:** One set of nationally-standardized qualifying scores has been established for all USEF/USDF Regional Championships, for Training Level through Grand Prix, in three divisions: open, adult amateur and junior/young rider. FEI Junior and FEI Young Rider classes have only one respective division. Freestyles have only open divisions.

Membership Requirements for USEF-licensed/USDF-recognized Competitions:

Owners and riders, including foreign riders

and owners who are not residents of the US, wishing to participate in a USEF-licensed/USDF-recognized competition as a rider or owner/lessee, must have either a USDF Group Membership (GM), Participating Membership (PM), or have a USDF Non-Member (NM) identification number and pay the USDF Non-Member (NM) fee. (Note: USDF Business Members can own horses but cannot compete as riders with their USDF Business Membership.)

Horses competing at USEF-licensed/USDF-recognized competitions must have either a USDF Horse Identification (HID) number or a USDF Lifetime Horse Registration (LHR). Proper credentials or verification certificates must be presented to the competition secretary.

Riders and owners wishing to participate in a USEF-licensed/USDF-recognized competition, and not able to present the competition secretary with verification of a USDF membership or NM identification, and USDF LHR or USDF HID, must complete a USDF Competition Affidavit Form and pay the \$5 affidavit filing fee. A copy of a completed affidavit form from another competition may also be used for verification purposes for up to 60 days. (Exception: Affidavits cannot be used at Great American Insurance Group/USDF Regional Dressage Championships.)

#### **Exceptions:**

- Horses competing only in Individual Breed Classes (IBCs) at DSHB competitions, sires and dams of horses in DSHB group classes, where those
  sires or dams are not actually competing in the same competition, horses competing only in breed restricted dressage or DSHB classes at
  Regular Competitions (e.g. all Arabian, all Friesian, or all Morgan classes), or in USDF Introductory Level tests, pas de deux or quadrille, are
  exempt from this requirement. Also exempt are horses ridden in leadline, exhibitions, games and races, classes for 4-H members, walk-trot,
  academy, and opportunity classes.
- Riders and owners/lessees competing only in classes which are exempt from the USDF HID requirements are also exempt from the USDF NM
  identification number and NM fee requirements. Also exempt are handlers of horses competing in DSHB In-Hand or Group classes.

#### **Memberships Defined**

Participating Membership (PM): A membership issued to an individual directly by USDF. The membership year is December 1 through November 30. PMs are available for 1-year (\$90), 5-years (\$360), or life (\$1,800). A USDF Youth Participating Membership (YPM) is available for individuals who have not reached their 21st birthday by December 1 of the current membership year (\$72). A PM allows the member to compete at USEF-licensed/USDF-recognized competitions and to participate as a rider and/or owner/lessee for all Adequan®/USDF Year-End Awards and the Great American Insurance Group/USDF Regional Dressage Championship program.

**Group Membership (GM):** A membership issued to an individual by USDF when the member name and dues are submitted to USDF through an affiliate Group Member Organization (GMO). The GM year begins December 1 and ends November 30. A GM allows the member to compete at USEF-licensed/USDF-recognized competitions and participate in the USDF Rider Awards Program and the USDF Regional Schooling Show Awards Program. **Business Membership (BM):** A membership that runs December 1 through November 30 and is issued to a business or organization directly by USDF. The USDF BM (\$240) offers a wider variety of advertising benefits. BMs satisfy requirements of horse ownership only.

Non-Member (NM) Identification Number: For each USDF NM owner/lessee and USDF NM rider there will be a USDF NM fee of \$35 per competition that must be collected by the show secretary and submitted to USDF, along with the USDF Report of Fees document and the \$5 affidavit fee and Competition Affidavit Form if the person cannot provide a copy of their USDF NM card. Owners/lessees or riders exempt from the NM number requirements are also exempt from paying the USDF NM fee. If there are multiple owners of a horse and all are NMs, only one of the owners must pay the NM fee. If the horse has at least one owner who is a current USDF PM, GM, or BM there is no NM fee assessed. Competition management will be invoiced for all applicable USDF NM fees not received with the USDF post-competition paperwork, along with a report listing all USDF NMs. Competition management is then required to submit the NM fees within 30 days to the USDF. An individual with a USDF NM identification number is not eligible for any USDF membership benefits. Once a USDF NM number has been assigned, a USDF NM card can be obtained from the USDF website.

Horse Identification (HID) Number: A one-time tracking number for horses (\$35). Scores earned by a horse with an HID number will be recorded, but will NOT be counted towards Adequan®/USDF Year-End Awards. A horse with an HID number is not eligible to compete in Great American Insurance Group/USDF Regional qualifying or championship classes. An HID number can be upgraded to a Lifetime Horse Registration (LHR) for a fee of \$80. If a horse has a USDF LHR it does not need an HID number. An HID number is a one-time fee that does not need to be renewed.

**Lifetime Horse Registration (LHR):** A horse with an LHR (\$115) is eligible for Adequan®/USDF Year-End Awards, and eligible to compete in Great American Insurance Group/USDF Regional qualifying and championship classes, assuming requirements for the owner and rider are met. If a horse has an LHR it does not need an HID number. An LHR does not need to be renewed.

#### **How to Join USDF**

Applications for USDF Participating Membership (PM), Business Membership (BM), Horse Identification (HID) number, and Lifetime Horse Registration (LHR) may be found in the following locations:

- On the USDF website: www.usdf.org. You can submit the application online or download the form and fax or mail it to the USDF office.
- In the show office at USEF-licensed/USDF-recognized competitions classified by USEF as Dressage Competitions, and Regular Competitions which are open to all breeds.

The effective date of membership is the date the form and correct fees are received in the USDF office or, if applying at a competition, the date accepted by the competition secretary, provided the application is signed and dated by the competition secretary, member, and/or horse owner on that same day.

# USDF Statement on Animal Welfare

The United States Dressage Federation, Inc. (USDF), a federation of over 100 independent organizations throughout the United States with a membership of nearly 30,000 members, supports the concept of ethical treatment of animals.

Dressage is a classical method of training horses, based upon the horse's natural responses, as carried out in a gradual, planned program during which the horse's athletic abilities are improved in a systematic manner. As a result, the horse becomes capable, comfortable, and responsive in partnership with the rider without the use of force. Dressage competition at various levels of achievement is the ultimate test of the training program to determine whether the desired harmony between horse and rider has been achieved.

The rules pertaining to dressage competition prohibit the use of artificial appliances, training aids, and drugs, which would force the horse to submit. Instead, the emphasis is upon training and a cooperative partnership with the rider. Major competitions are carefully monitored to assure that there is no unnecessary force or harshness displayed.

Unlike other horse sports in which horses enter training at a relatively immature state, dressage training is usually not seriously begun until the horse is three or four. The top levels of achievement require five or more years of progressive training and it is not unusual to see horses in international competition in their late teens. This, in itself, places a premium on good care and soundness throughout the horse's life.

While supporting the concept of animal welfare in its broadest form, the United States Dressage Federation, Inc., also recognizes that it is unrealistic to ascribe human emotions and responses to the horse which in its wild state is a creature of flight, living a hard and precarious existence. Under domestication, the horse is assured of ample food, water, and shelter, as well as protection against infectious diseases and damaging parasites, thus leading a longer and healthier life with a high rate of survival.

As an educational organization, USDF has numerous programs, which teach people how to pursue the accepted, humane training methods. A program of certifying instructors also emphasizes protecting the horse's welfare in pursuit of dressage training.

# **USEF Equine Vaccination Rule**

From the USEF Communications Department

**Lexington, Ky.** - In January, the USEF Board of Directors approved an addition to the rule book, which outlines equine vaccination requirements at licensed competitions. Beginning December 1, 2015, all horses entering the grounds of a Federation-licensed competition must be accompanied by documentation of Equine Influenza Virus and Equine Herpes Virus (Rhinopneumonitis) vaccinations within six months prior to entering the stables.

Due to several high profile Equine Herpes (EHV) outbreaks in recent years that have involved the neuropathic strain of the virus (equine herpesvirus myeloencephalopathy-EHM), some competitions have placed vaccination requirements on their competitors that go beyond most accepted medical opinions and raise concern that unnecessary requirements can potentially put a horse at risk. The intent of this rule is to ensure that all licensed competitions comply with the vaccination guidelines for Equine Influenza and Equine Herpes (Rhinopneumonitis) published by the American Association of Equine Practitioners (AAEP). These guidelines are reviewed by infectious disease experts regularly, and recommend vaccinating competition horses at six-month intervals for both equine influenza (flu) and rhinopneumonitis (EHV-1 and EHV-4). There is not a vaccine that protects against EHM.

Intended to promote proper vaccination protocols, this rule does not anticipate an increased workload for competition management. The flu vaccination information can be added to the documentation already required by most competitions: a horse's health certificate and a negative coggins test.
